INCORPORATED IN 2004, AFTER MANY YEARS OF GRASSROOTS ORGANIZING AND COMMUNITY COLLABORATION, THE COCOON OPENED ITS DOORS ON JUNE 14, 2005. PRIOR TO THIS TIME, VICTIMS IN WOOD COUNTY NEEDING SHELTER WERE FORCED TO FLEE THEIR HOMES, LOSE THEIR PERSONAL SUPPORT SYSTEMS, AND TRAVEL LONG DISTANCES TO SHELTERS, PRIMARILY IN FOSTORIA, TOLEDO, AND FINDLAY.

THE COCOON SHELTER OPENED ITS DOORS WITH ONLY ONE PAID STAFF MEMBER AND HAS GROWN TO HAVE 18 STAFF POSITIONS WORKING 24 HOURS A DAY TO PROVIDE COMPREHENSIVE SERVICES TO VICTIMS OF ABUSE IN WOOD COUNTY.
