4a (Code: ) (Expenses \$ 1,308,700. including grants of \$ ) (Revenue \$ ) IN 2021, THE COCOON PROVIDED SERVICES TO 818 SURVIVORS OF DOMESTIC AND SEXUAL VIOLENCE, UP FROM 747 SURVIVORS IN 2020, PROVIDED 63 INDIVIDUALS WITH EMERGENCY SAFE SHELTER, OF WHICH 20 WERE CHILDREN, ASSISTED 233 SURVIVORS IN OBTAINING A CIVIL PROTECTION ORDER, RESPONDED TO 35 CALLS FOR ASSAULT SUPPORT AT THE HOSPITAL AND 156 SURVIVORS ATTENDED OUR WEEKLY SUPPORT GROUPS. WE ANTICIPATE SIMILAR NUMBERS IN 2022. AS THE PANDEMIC CONTINUES, THE NEED FOR SERVICES IS GREATER THAN EVER, ESPECIALLY WITH THE REPORTS OF INCREASED VIOLENCE OCCURRING IN THE HOME. IN MARCH 2020, OUR DOMESTIC VIOLENCE CALLS INCREASED 40% AND AS RESTRICTIONS BEGAN TO LIFT, WE SAW A 50% INCREASE IN SEXUAL VIOLENCE REPORTS. SEE SCHEDULE O FOR CONTINUATION
